1. The Ministry of Finance has received a budget allotment from the Government of Liberia and intends to apply a portion towards the Construction of Cash Centers.
2. The GOL Ministry of Finance now invites qualified and eligible bidders to submit bids for these Constructions. The procurement procedures applicable are the Republic of Liberia PPCC Act of concessions published and approved: September 2005. Bidding will be conducted through National Competitive Bidding (NCB). Bidding is open to all eligible and qualified bidders.
3. Interested and eligible bidders may obtain further information from and inspect the bidding documents at the office of the MOF Procurement Director address specified below. Late bids will be rejected and returned unopened. **Bids must be submitted at the Security Desk, ground floor of Ministry of Finance on or before 15:00 hrs on 25 June 2010.** Submissions must be clearly marked with the lot number and other information including the inscription: CONFIDENTIAL - (County/Location) Bid. *Bidders can only bid for one lot.*

6. Opening will be done promptly after closing at 15:00, 25 June 2010 in the conference room of the Ministry of Finance 10th floor. Bids will be opened in the presence of bidder's representatives or those who choose to attend on or before 14:00 pm, 25 June 2010.
7. Ministry of Finance reserves the right to reject any bid. Invitation to bid and award of contract will be issued to qualified bidders in accordance with procurement procedures applicable under the Republic of Liberia PPCC Act of concessions published and approved: September 2005. Ministry of Finance projects are pre-financed up to thresholds of 30% completion. **Consideration will be given to firms with requisite technical and financial capacity to implement projects including offices or work experience in county/bid of choice.
